Children must be four years of age by September 1, 2010 to attend and be toilet trained.

DISCOUNT: A 10% discount will be given if a child has a sibling enrolled in Our Lady of Mercy School. Before Care is available from 7:00am-8:00am AND Extended Day Care is available from 2:30pm – 5:30pm on a first-come first-serve basis. Sign up forms will be sent out at a later date.

Tuition is paid to OLM DIRECTLY OR through the use of the FACTS tuition program. Necessary paperwork and FACTS contracts will be sent at a later date.

OPTIONS ARE:

1. Full payment made directly to Our Lady of Mercy School by August 1<sup>st</sup> with a \$100.00 deduction.
2. Ten Monthly payments made to FACTS; payments are taken directly out of accounts on the 5<sup>th</sup> or 20<sup>th</sup> of each month based on your choice.(Aug-May)

REFUND POLICIES

If enrollment for the 2010-2011 school year is to be cancelled, written notice must be given to the School Office prior to August 1, 2010. If tuition has been paid it will be returned less the \$100.00 deposit. The refund policy for cancellation after August 1, 2010, as follows:

- (A) If cancelled between August 1, and November 1, the parent is responsible for 25% of the annual tuition;
- (B) If canceled up until February 1<sup>st</sup> the parent is responsible for 50% of the annual tuition.
- (C) If canceled after February 1<sup>st</sup> there is no refund and the parent is responsible for the full tuition. Consideration will be given to special circumstances.
